

**NOTICE OF NEW HAMPSHIRE MEDICAID

The New Hampshire Pharmacy and Therapeutics Advisory Committee (PTAC) invites you to attend a public hearing at 2:00 p.m., on June 19, 2008 at the Howard Recreation Center, 99 Pleasant Street, State Office Park South, Concord, NH. A PTAC meeting will immediately follow this public hearing.

The purpose of the public hearing on June 19, 2008, is to solicit information and provide an opportunity for the public to present its views regarding the NH Medicaid preferred drug list and pharmacy prior authorization criteria.

The public hearing will begin at 2:00 p.m. and end no later than 3:00 p.m. The PTAC meeting will begin at or before 3:00 p.m., upon completion of public comments. The public is invited to present oral comments regarding the prior authorization criteria for the June 19, 2008 public hearing. Members of the public shall notify the Department of Health and Human Services (DHHS) at least 48 hours in advance of the public hearing of their intent to comment at the public hearing. Comments will be limited to no longer than five (5) minutes per person and will be limited to the items on the agenda as they relate to the preferred drug list and prior authorization criteria.

Written material may also be submitted by the public for PTAC consideration if received by DHHS at least 48 hours in advance of the meeting and may not exceed five (5) pages in length.
